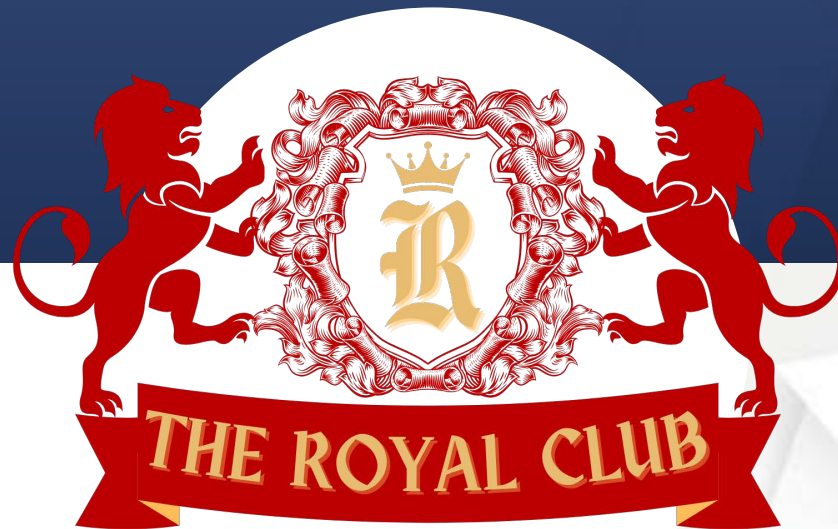

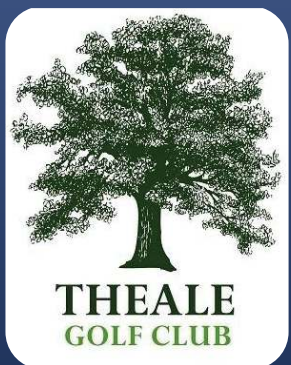

They will not retire by rotation and cannot be included a part of the total directors to facilitate computation of rotational directors.

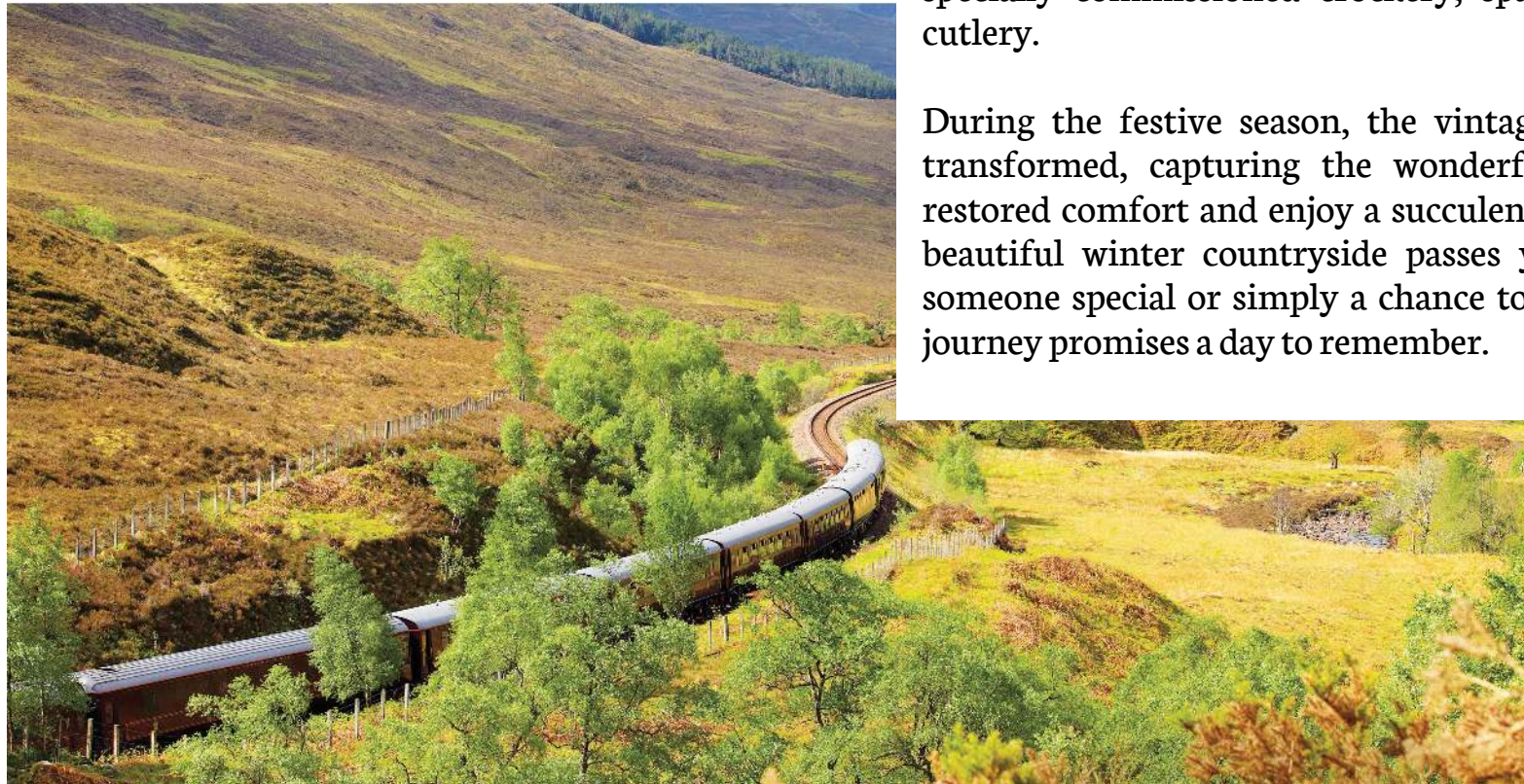

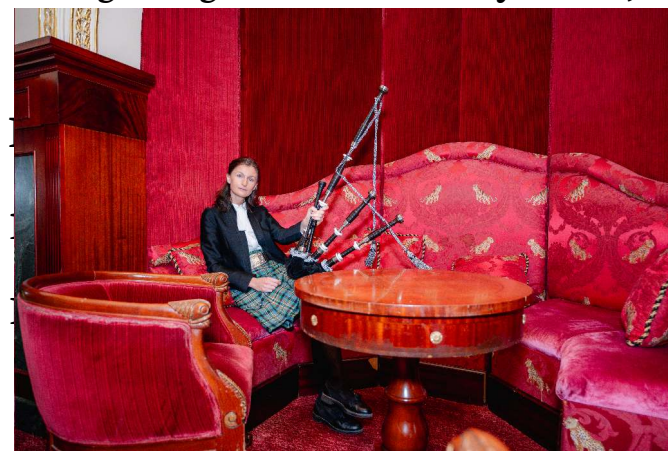

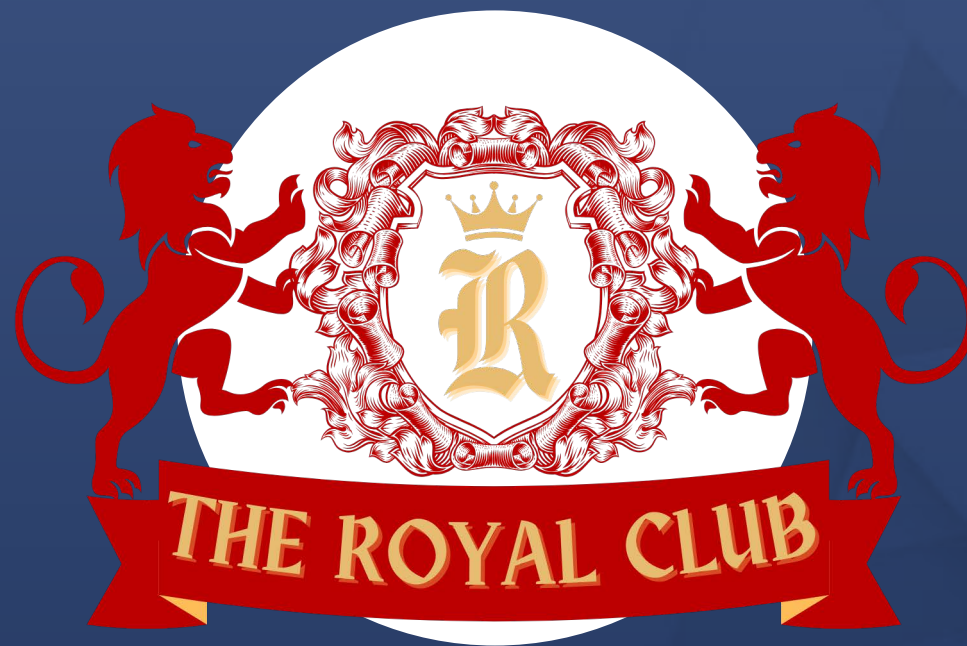
